Only manuscripts written in English are considered for publication. Type the manuscript on A4 size, i.e., 210 by 297mm white sheets according to the following format in camera-ready style.

**Page Format**

The manuscript should be submitted in the final format with a 2-column format on A4 size sheets. Each column is limited to 82mm in width with a 6mm gutter between columns. The margins are 20mm on the sides. The margin including header is 25mm. The margin on the bottom is 25mm. Text is to be typed single spaced in 10 point Times Roman (or a font closely resembling this type), with 12 point interline spacing.

**Title Page**

The first page of the manuscript, centered on the top below the top margin, should include the paper title (16 point, bold), authors' full names [first name, middle initial(s), surname] (12 point with 8 point for superfix), affiliations (10point *Italic*), abstract of less than 200 words (10 point with 10 point bold *Italic* head), and keywords (10 point *Italic*). The first author's information of author's name, fax number, phone number, and e-mail address should be included in a footnote of the left column at the first page.

**Text:** All manuscripts should be 10 point.

**Headings and subheadings and caption**

Headings and subheadings of each chapter and captions of each table, figure and photograph should be 12 point, bold, and centered.

**Figures:** Figures should be high-quality professionally drawn, high-resolution computer generated, or glossy, high-contrast, black and white photographs. Authors requiring the use of color illustrations should contact the publisher.

**Figure Legends:** Legends should be typed double spaced and numbered with Arabic numerals corresponding to the illustrations and submitted on a separate page. If the figure has been previously published, a credit line should be included.

**References**

References should be written as in the example below:

**Page length**

The standard length of a paper is six pages, and total number of pages should never exceed 10 pages.

Full-length Paper: between six and ten pages

Short-length Paper: four or five pages

Your manuscript should be submitted to the Journal office with a choice of Full-length paper or Short-length paper.

Authors whose native language is not English are strongly advised to have their manuscripts checked by an English-speaking colleague prior to submission.

**Accepted Manuscripts**

Manuscripts that have been accepted for publication should be returned in complete camera-ready form to the Editor. The completed manuscript should include all original figures tables and photographs. At the end of the manuscript, brief authors' history (8 point) under the name of each author (8 point, bold) should be type-written including a space of 25mm x 30mm for each author's photograph The photograph of each author should be sent to the Editor together with the original completed manuscript and its one copy.
